Grade 4-6 Ski Day at Little Smoky Ski Area

We are excited to offer all our Grade 4-6 students a Ski Day on <u>March 11</u>!! Our students will be bussed to Little Smoky Ski Area at 8:30am on March 11, and will return to Bezanson around 3:30pm, in time to catch their bus home.

You will find attached the following forms to be filled out for your child:

- 1) Bus Permission Form required for ALL students
- 2) Snowboarding/Skiing Waiver required for ALL students for Snowboarding/Skiing.
- 3) Snowboard/Ski Rental Form required for any students who will be renting equipment.

Little Smoky has a flat rate fee for both lift tickets and rentals (should you require them). Please attach your payment of **\$27.50** to your forms for lift tickets and/or rentals.

The kitchen will be open at the ski hill. Students are welcome to buy lunch there, or bring a bag lunch. Personal items cannot be brought into or stored in the chalet so please do not bring more than you absolutely need! Outside lunches cannot be brought into the chalet, and they ask that all those using the chalet be considerate of others who may be waiting to come in to eat as they need to limit the numbers permitted in at a time.

If you have more than one child, you are welcome to pay with one cheque, but please attach all the forms to the payment. All cheques must be payable to <u>Bezanson School</u>.

We hope all our Grade 4-6 students will be able to join us for this fun day! If the cost makes this program prohibitive for your family, please contact the school as we will do everything we can to have all our students join us for the day.

For those students that own skis/snowboards, we ask parents to please **clearly label** their child's gear and have it at the school by 8:10am March 11 to be loaded into a staff member's truck for delivery to the ski hill.

ASSUMPTION OF RISKS

I am aware that skiing and snowboarding involve many risks, dangers and hazards including, but not limited to: boarding, riding and disembarking ski lifts; changing weather conditions; avalanches; exposed rock, earth, ice and other natural objects; trees, tree wells, tree stumps and forest deadfall; the condition of snow or ice on or beneath the surface; variations in the terrain which may create blind spots or areas of reduced visibility; variations in the surface or sub-surface, including changes due to manmade or artificial snow; variable and difficult conditions; streams, creeks, and exposed holes in the snow pack above streams or creeks; cliffs; snowcat roads, road-banks or cut-banks; collision with lift towers, fences, snow making equipment, snow grooming equipment, snowcats, snowmobiles or other vehicles, equipment or structures; collision with other persons; loss of balance or control; failure to act safely or within one's own ability or to stay within designated areas; negligence of other skiers, snowboarders and other persons; and NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE. I am also aware that the risks, dangers and hazards referred to above exist throughout the ski area and that many hazards are unmarked. I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, OR PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees accepting my application for a Season/Daily pass and permitting my use of the lifts, ski runs, trails, terrain parks, race courses, restaurants, day lodge and other ski area facilities (hereinafter "the facilities"), and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my use of or my presence on the facilities DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER ANY APPLICABLE OCCUPIERS' LIABILITY LEGISLATION ON THE PART OF THE RELEASEES, AND ALSO INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS REFERRED TO ABOVE;

- I accept full responsibility for the care of the rental equipment ("the Equipment") listed on this form and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned by the agreed date.
- I am familiar with the proper use of the Equipment.
 I understand that the rental technicians are able to answer questions I may have as to the proper use of the Equipment.
- 3. I have made no misrepresentation in regard to my height, weight, age or skier type. (This information is required in order to properly adjust the ski boot/binding settings). I agree to verify that the settings appearing in the visual indicator windows on the bindings correspond with the settings to be recorded on this form.
- I also agree to return the Equipment in clean condition to avoid any additional charges.

ASSUMPTION OF RISKS

I am aware that skiing and, snowboarding involve risks, dangers and hazards and that injuries are a common and ordinary occurrence of these sports.

SKIING I understand that the ski boot/binding system may not release during every fall or may release unexpectedly. The ski boot/binding system is no guarantee that the user will not be injured.

SNOWBOARDING I understand that the boot/binding system in not designed or intended to release and will not release under normal circumstances. I understand that as the boot/binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

HELMETS I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognise that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT.
